TERMS AND CONDITIONS for Cruising on our vessel the M.V. Mudjimba

- **Bookings will not be confirmed until deposit is received.** No responsibility will be taken for loss of bookings resulting from non-payment of deposit within the required 24 hours of verbal confirmation of booking.
- Deposit is non-refundable. Full payment of balance required within 2 days of cruise date. Please note that our vessel **will not** depart the wharf under any circumstances unless full payment has been received in advance.
- If the cruise is cancelled by us due to unforeseen circumstances, you will be offered a full refund, or you can re-book.
- Departure time to be arranged at time of booking with **5:00pm** being the latest. Departure times that you arrange will be strictly adhered to. If we leave late due to unexplained late arrivals, the cruise will remain 2 hours from the departure time that was arranged. We will allow time prior to your cruise for you to set up. Usually half an hour is sufficient.
- BYO food and drinks allowed. **UNDER NO CIRCUMSTANCES DO WE ALLOW ALCOHOL IN THE FORM OF NEAT "SHOTS". THIS WILL NOT BE ALLOWED TO BE BROUGHT ON BOARD.** Beer, wine, and pre-mixed canned spirits only.
- Table available. Please **DO NOT** place any food items on the seats.
- BYO disposable tableware. Glasses available on request.
- BYO alcohol allowed **on board our vessel only**. No BYO alcohol to be consumed within the Wharf Complex prior to, or after the cruise (strict Wharf Management policy applies).

- The Skipper is authorised to abort the cruise **AT ANY TIME** due to behaviour which may result in damage or harm to the vessel M.V. Mudjimba and/or any person/s on board, and for any behaviour which the Skipper deems inappropriate.
- We ask that you consume alcohol responsibly in a manner that does not offend others around you, whether they be on our vessel itself, or in the surrounding waterfront community.
- If you are intoxicated prior to boarding you may not be able to board our vessel, this is at the discretion of the Skipper. If you become unduly intoxicated whilst onboard, our vessel may stop at the safest available pontoon and require you to disembark. If deemed necessary, the Skipper may elect to dock our vessel and remove the guest and notify police. Rowdy or unruly behaviour will not be tolerated.
- Any costs associated with the early termination of the cruise due to unacceptable behaviour and or damage to our vessel The M.V. Mudjimba, must be paid for by the guest.
- Since food is BYO, the Skipper and owners accept no responsibility for any problems/illnesses/allergies arising from the consumption of food eaten on board.
- Surveillance camera in operation at all times. Charges will apply for any damage caused to the M.V. Mudjimba.
- It is our responsibility to maintain a safe environment for our passengers on board our vessel, and to supervise evacuation procedures in the unlikely event of an emergency. Children however, during general cruise operations **are not** the responsibility of the Skipper and crew aboard the vessel, and must be supervised **AT ALL TIMES**, by the responsible adult/s accompanying them on the cruise.
- Canned beer preferred on board the vessel. Disposable drinkware only (no glass).
- Smoking is **strictly prohibited** on board the vessel. The cruise will be aborted if anyone is found smoking. Strictly **NO STOPPING** to allow passengers to alight the vessel for the purposes of smoking.
- Small toilet on board if necessary. We respectfully request you use the land facilities prior to your departure if required.
- Personalised decorations allowed subject to prior application/approval of the owners. All decorations must be environmentally friendly. The Skipper is authorised to refuse any decorations deemed non-compliant with local Council and State environmental regulations.
- Music is permitted. However, please note that noise levels in built-up residential areas will be controlled by the Skipper in adherence with local Council and State Government regulations.
- Patrons are asked to vacate our vessel in a timely and orderly manner on completion of the cruise.
